Based on recent discussions with the Borough, it is our understanding that, consideration is being given to the elimination of parking on one side of Broad Street between Church Street and the Route 12 Circle. A Municipality may, without the approval of the Commissioner of the NJDOT, establish by Ordinance provisions of New Jersey Statutes, Title 39 – Chapter 4 – Traffic Regulation. This includes provisions of R.S.39:4-197, which includes regulation of the parking of vehicles on streets, including enforcing the parking restriction with parking signs. However, Title 39 indicates that the Municipal Engineer must first certify under a Professional Engineer seal that any designation or erections of signs has been approved by the Engineer after investigation of the circumstances, and conforms to the current standards prescribed by the Manual on Uniform Traffic Control Devices (MUTCD). It further states that not only must it be consistent with the MUTCD, it must also be based on the results of an accurate traffic and engineering survey.

Currently, the parking on both sides of Broad Street is permitted. It is the intent of this analysis to evaluate the existing field conditions, in conjunction with the MUTCD, Borough Design Standards and the N.J.A.C. 5:21, Residential Site Improvement Standards, in order to evaluate the viability of prohibiting parking on one side of the street. We anticipate that performing the following tasks will be included:

- Perform site visit and inventory existing conditions, including field measurements of roadway width and traveled way width between the parking.
- Review Borough Design Standards and RSIS Standards to Evaluate deficiencies (if any) revealed by the existing measurements with parking on both sides allowed.
- Request and review crash data for the last three years from the Borough Police Department.
- Review Borough Ordinances to review any existing parking restrictions.
- Prepare a Summary Report including recommendations.
- Provide Professional Engineer certification if required.





Based on recent discussions with the Borough, it is our understanding that, consideration is being given to the installation of one or more pedestrian midblock crosswalks adjacent to local businesses on Stangl Road. A Municipality may, without the approval of the Commissioner of the NJDOT, establish by Ordinance provisions of New Jersey Statutes, Title 39 – Chapter 4 – Traffic Regulation. This includes provisions of R.S.39:4-197, which includes regulation of the midblock crosswalks on streets including needed signs and other traffic control devices related to the crosswalk. However, Title 39 indicates that the Municipal Engineer must first certify under a Professional Engineer seal that any designation or erections of signs or traffic control devices has been approved by the Engineer after investigation of the circumstances, and conforms to the current standards prescribed by the Manual on Uniform Traffic Control Devices (MUTCD). It further states that not only must it be consistent with the MUTCD, it must also be based on the results of an accurate traffic and engineering survey.

We understand the Borough wishes to consider crosswalks at two locations. The first crosswalk location is approximately 175 feet to the south of Mine Street along Stangl Road on the left and right curb islands, and the second crosswalk location is approximately near the unsignalized intersection of Reasoner Lane and Stangl Road by the Long Eagle Brewing Co. It is the intent of this analysis to evaluate the existing field conditions in conjunction with the MUTCD in order to evaluate the viability of implementing pedestrian midblock crosswalks at these locations. We anticipate that performing the following tasks will be included in the Stangl Road Pedestrian Midblock Crossings Analysis:

- Perform site visit and inventory existing conditions.
- Collect Vehicular Traffic Volumes utilizing an Automated Traffic Recorder (ATR) placed within the vicinity of the main pedestrian crossing location. The ATR will collect data for the various cars, buses, trucks, etc. passing through the site for 1 full week. The data from the ATR will be utilized to establish the Average Daily Traffic (ADT) on Stangl Road.
- Collect and Evaluate Pedestrian Traffic Volume Data through Manual Pedestrian Counts for six hours during a typical peak period at the main pedestrian crossing location. Collect and

evaluate the pedestrian gaps to establish the number of gaps available for the pedestrians to cross the roadway.

- Request and review crash data for the last three years from the Borough Police Department.
- Request and review speed data from the Borough Police Department.
- Evaluate the field conditions and the data collected in accordance with the engineering study criteria set forth in the MUTCD relative to installing midblock crosswalks and additional enhanced signing, striping, and other traffic control devices as necessary.
- Review available sight distance at the proposed crosswalk locations in accordance with American Association of State Highway and Transportation Officials (AASHTO) standards.
- Prepare a Summary Report including recommendations.
- Prepare an Engineer's Certification

Upon completion of our evaluation in accordance with MUTCD and NJAC Title 39, considering all of the factors outlined above, CME Associates will provide an engineer's certification with the submission should the findings of the study conclude that the proposed modifications are feasible and in the best interest of the public.

The actual plan layout, construction details, and technical specifications of any viable crosswalks are not included in the proposal but can be developed under a separate authorization if necessary.

### Description of work:

In accordance with the Borough's request, we have prepared the following estimates in order to provide you with initial order of magnitude Project Costs for the above referenced Project. The project limits consist of William Street between Broad Street and Elwood Avenue.

It is anticipated that the scope of improvements will generally include asphalt pavement milling including base repair where necessary; removal and replacement of concrete curb, concrete sidewalks and driveway aprons if and where necessary; reconstruction of the existing curb ramps at the northeast and southeast corners of the Broad Street intersection; adjusting castings to grade; traffic signing and striping; storm sewer improvements; landscaping and associated restoration; and the construction of hot mix asphalt surface and leveler course. The proposed improvements will also include the replacement of the existing water main within the limits of the Project.

It should be noted that the adjacent residential properties at the Broad Street intersection are reportedly historically significant including the stone existing stone masonry retaining walls located along the back edge of sidewalk. Accordingly, it is anticipated that the approach sidewalk reconstruction associated with the curb ramps at the Broad Street intersection will match the existing sidewalk width in order to protect the existing retaining walls. Therefore, sidewalks under proposed condition may be less than 4-feet wide. It should also be noted that the proposed curb ramps at the Broad Street intersection will be ADA accessible to the greatest extent practicable given the existing constraints at these corners, and we anticipate that ADA Technically Infeasible Forms will be required for these curb ramps.

As you are aware, the Borough of Flemington received a Municipal Aid Grant in the total amount of \$162,360.00 for this Project. It should be noted that the Fiscal Year 2022 Municipal Aid Grant has a contract award deadline of March 1, 2024.





**An Ordinance to Amend the Code of the Borough of  
Flemington by Adding Section 2-30 Establishing a  
Community Emergency Response Team (CERT) Program**

**WHEREAS**, the Mayor, Borough Council, and the Borough Emergency Management Coordinator recognize the willingness of local residents to be involved in their community by volunteering during times of disaster; and

**WHEREAS**, the Federal Emergency Management Agency ("FEMA") offers a Community Emergency Response Team ("CERT") Program which educates people about disaster preparedness for hazards that may impact their area and trains them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations; and

**WHEREAS**, using the training learned in the classroom and during exercises, CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help; and

**WHEREAS**, CERT members are encouraged to support emergency response agencies by taking a more active role in emergency preparedness projects in their community; and

**WHEREAS**, the CERT course will provide the auxiliary members the training to respond to and cope with the aftermath of a disaster; and

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Flemington, in the County of Hunterdon, in the State of New Jersey that Section 2-30, entitled "Community Emergency Response Team" is hereby added as follows:

**Section 2-30 Community Emergency Response Team**

a. **Establishment.** Under the direction of the Borough's Emergency Management Coordinator there shall be established a Community Emergency Response Team (CERT) created to serve as auxiliary members of the Office of Emergency Management during disasters and special events.

b. **Membership.** All members of the Community Emergency Response Team (CERT) will be appointed by the Governing Body, and will be required to complete the training offered by FEMA or the County of Hunterdon Office of Emergency Management.

c. **Purpose.** The purpose of the CERT Team is as follows:

1. Supplement the Borough's response capability after a disaster or during special events, serving as auxiliary members of the Office of Emergency Management;

2. During and after an emergency or disaster, provide immediate assistance to victims, organize spontaneous volunteers who have not had the training and collect disaster intelligence that will assist professional responders with prioritization and allocation of resources following a disaster;

3. Provide assistance with traffic flow when needed;


- 4. Participate in meetings for the Office of Emergency Management;
- 5. Provide assistance to other communities located in the County of Hunterdon.
