

# BOROUGH OF FLEMINGTON REGULAR COUNCIL MEETING DECEMBER 11, 2023

Mayor Karrow called the meeting to order at 7:03 p.m. announcing that all laws governing Open Public Meetings Act have been met and that this meeting has been duly advertised.

PRESENTATIONS: Catherine Suttle from Hunterdon Land Trust – Dvoor Farm Project

Catherine Suttle, Executive Director from Hunterdon Land Trust explained that the Hunterdon Land Trust preserves farm land and open space in Hunterdon County. Ms. Suttle discussed the Dvoor Farm which is the only preserved land that has buildings on it. Ms. Suttle explained the three phases of the project. Phase I is design, engineering, interim power supply, demolition, asbestos removal, structural repairs, siding, windows, exterior doors, roofing, insulation and framing off addition rehabilitation which will cost \$2.6M. Phases II is new utilities to site including water hook up, septic and electric service, mechanical & electrical work in the barn, warming kitchen, elevator, interior partitions for bathroom, stairways, lobby area, interior finishes which will cost \$3.9M. Phase III is earthwork, parking area, new driveway, sidewalks, landscaping, storm systems and site lighting which will cost \$1.3M. Mayor Karrow asked the time frame of each phase. Phase I will be completed by May 2024, Phase II and Phase III will be on how quickly they can raise money. The Hunterdon Land Trust is requesting Flemington Borough to consider a \$100,000 donation. Mayor Karrow stated the Council can discuss the donation during the budget process.

# **FURTHER DISCUSSION AND VOTE ON ORDINANCE:**

ORDINANCE 2023-30 AN ORDINANCE AMENDING CHAPTER VII TRAFFIC, SCHEDULE I NO PARKING, AND SCHEDULE XV, PARKING PERMITS BY ADDING A RESIDENT PARKING PERMITTED AREA DURING CERTAIN HOURS ON THE NORTH SIDE OF CAPNER STREET

Mayor Karrow stated she received support for this Ordinance from Chief Rotella and DPW Supervisor, Mike Campion.

Council Vice President Tilly stated the DPW would have a hard time plowing Capner Street with cars parked along the street, she also thinks parking on both sides on the street is a safety issue.

Council President Long asked what was the origin of this Ordinance. Mayor Karrow stated she bought it up with the Council and then met with Hunterdon County to talk to them about residents parking on Capner Street.

Councilwoman Engelhardt asked if Council can table the Ordinance until there is more feedback from the residents.

Council Vice President Tilly suggested Council look at the parking lot behind the post office for additional parking. Mayor Karrow stated the Borough owns that lot and she will talk to Hunterdon County again.

Council agreed to introduce the Ordinance again in 2024.
