Mayor Driver called the meeting to order at 5:00 p.m.

Ms. Tilly was sworn in at Borough Hall earlier in the day by Clerk Graziano.

NJ Lt. Gov. Sheila Oliver swore in Council Member Johnston. Mr. Johnston thanked voters, said he was excited to serve and represent all residents, and thanked all his supporters.

#### II. Mayor's Report

Mayor Driver thanked her family for their support, particularly in the challenging year just passed. She gave an overview of the Borough's response to the COVID-19 virus, and said it served as a model for other communities. She thanked WBM for its contribution of PPE at a time when there were shortages. She called for a moment of silence to honor the three Borough residents who died of the virus. She said vaccinations hold out hope for the year ahead, but we must remain diligent and socially distant.

She discussed the ongoing development efforts in town including the Courthouse Square project, plans for the two Agway sites, Liberty Village, and infrastructure projects planned this year.

With the COVID-19 restrictions there will be no reorganization dinner this year to honor Borough employees, but she's hoping something can be arranged later in the year.

### III. Council Members' Comments

#### Council Member Long

Mr. Long congratulated his newly elected and re-elected colleagues, and talked about the challenges of governing during a pandemic - doing everything through online meetings, coming up with creative ways to complete the Census count, and share information.

He discussed his experience serving on the Planning Board, and working on the Citizens' Working Group with Ms. Hand and Chief Rotella.

His goals for 2021 include continuing to be available to residents, in the belief that exploring different perspectives will help build consensus. He intends to pursue adoption of bylaws, and said for the budget, a visual presentation is critical.

#### **Recognition of Assemblyman Andrew Zwicker**

Mayor Driver recognized Assemblyman Andrew Zwicker, who was participating in the online meeting. Mr. Zwicker congratulated the new and re-elected Council members. He commented on the challenges of the past year and said he's looking forward to continuing to work with Borough officials in the year ahead.

#### Council Members' Comments (Continued)

#### Council Member Hand

Ms. Hand said her work on the Citizens' Working Group was eye-opening and gives her hope for the future. Her goals for this year include getting the Community Garden up and running, and finalizing bylaws for Council.

#### Council Member Runion

Mr. Runion congratulated his newly elected and re-elected colleagues, and discussed the Environmental Commission's work over the past year, which included 3 site plan reviews. They are continuing to work on action items to attain Bronze-level status in the Sustainable Jersey program.

#### Council Member Giles-McCormick

Ms. Giles-McCormick congratulated the newly elected and re-elected Council Members, and said this year feels like it has a lot of potential, and the Borough is turning a corner. She said it's good to dream big, but balance that with what's

feasible. Discussions must not shut people out, and greatness comes from diversity. Regarding the Opportunity Zone discussions, she said an advisory group is helping them put all the suggestions together, and they've received a month's extension to complete the talks, due to the pandemic.

Council Member Tilly

Ms. Tilly thanked voters for returning her to office, thanked Council members for their good wishes, and welcomed Mr. Johnston to Council. She said she's looking forward to a productive year.

Council Member Johnston

Mr. Johnston thanked everyone again for their support.

#### IV. OEM Coordinator's Comments

Coordinator McNally said we're 42 weeks in to the COVID-19 public health emergency. When last before Council on 12/14, he was preparing for a major winter storm; he said the DPW did a great job cleaning up after the storm, and thanked residents and businesses for keeping the streets clear so plows could get through.

Regarding COVID, the Borough has had 262 positive cases since March, and 26 of those cases came within the last 7 days. Right now, the main effort is sharing information about vaccine distribution. We're currently in Phase 1A - mainly healthcare workers and EMTs. Phase 1B and 1C will follow - additional first responders, firefighters, police, and other essential workers. Phase 2 will be for the general public. He and the Mayor are planning a Facebook Live discussion on Thursday at 7 p.m., on the Borough's Facebook page. He warned people to watch out for vaccine scams.

## **Open Public Meetings Act Notice 2021**

### **BOROUGH OF FLEMINGTON**

---

**WHEREAS**, the Senate and General Assembly of the State of New Jersey have enacted an Act concerning meetings of certain public bodies known as "**The Open Public Meetings Act**" approved October 21, 1975, as Chapter 231, P.L. 1975 effective 90 days after enactment, to wit, on or before January 19, 1976; and

**WHEREAS**, it is deemed appropriate that the Common Council of the Borough of Flemington shall resolve in all respects to implement the provisions thereof, and in particular to adopt resolutions relating to the posting and distribution of a yearly schedule and any revised schedule of any regular meetings of the Common Council, as well as giving of advance notice of at least 48 hours of any regular, special or re-scheduled meeting thereof, designating at least two newspapers to receive such notices, and fixing fees to cover the costs of mailing to any person requesting copies of any regular meeting schedule or revision and any "48 Hours" advance written notice of any regular or re-scheduled meeting of the Common Council.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Common Council of the Borough of Flemington, County of Hunterdon, State of New Jersey as follows:

**1.** The regular meeting of the Mayor and Common Council of the Borough of Flemington shall be held on the **second** and **fourth** Mondays of each month during the calendar year, **2021**, unless otherwise noted. The meetings shall be held at Borough Hall, 38 Park Avenue, Flemington, New Jersey, unless otherwise noted. Meetings will start at 7:30 P.M. prevailing time.

**2.** A regular work session/ new business session/ executive session of the Mayor and Common Council of the Borough of Flemington shall be held on the **second** and **fourth** Mondays as needed, before the regular scheduled meeting, during the calendar year **2021**. The posted agenda for each meeting will indicate if such session will occur and the nature of such session. The meetings shall be held at the location of the regular meeting, at 6:30 P.M. prevailing time.

**3.** If a state of emergency and public health emergency declared by Gov. Phil Murphy continues to exist, and in an effort to prevent the further spread of COVID-19, Flemington Borough Council meetings will be conducted through an electronic system only until further notice. Council is using the Zoom platform for these meetings.

**5.** The Hunterdon County Democrat is hereby designated as the official newspaper of the Borough of Flemington, with the Courier News as an alternate. TapInto.net is designated as an official online news source of the Borough of Flemington.

**6.** Upon prepayment of the sum of \$10.00 by any person requesting that the Clerk mail him/her copies of any annual regular meetings scheduled or revision thereof or requesting that the Clerk mail him/her advanced written notice of any regular, special or re-scheduled meeting of the Mayor and Common Council, the Clerk shall mail to such person so requesting a copy of any such schedule or written notice.

7. Notice requested by news media, other than those specifically enumerated in paragraph 3 above, shall be mailed to any such other news media, upon written request, without charge or fee.
