WHEREAS, the Borough was utilizing Municipal Software for its tax collection service; and

WHEREAS, Municipal Software was purchased by Edmunds Govtech; and

WHEREAS, the Borough had to convert to the new Edmunds Software for tax collection; and

WHEREAS, during the data conversion there were several issues; and

WHEREAS, properties owing a figure of more than 6 digits were converted wrong; and

WHEREAS, the management company has requested the additional funds be refunded rather than credited.

WHEREAS, it is in the best interests of the School District and the Municipality to establish this program;
