as evidenced by the group affidavit form of the governing body; and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:2788-52 - to wit:

R.S. 52-2788-52 - "A local officer or member of a local governing body, who, after a date fixed for compliance, fails or refuses to obey an order of the Director of Local Government Services, under the provision of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

5. RESOLUTION 2023-171 – RESOLUTION AUTHORIZING THE ISSUANCE OF A CLASS 5 RETAIL LICENSE TO AUNT MARY'S

WHEREAS, pursuant to N.J.S.A. 24:6I-31 et seq., the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act ("the Act") authorizes the legal use of recreational cannabis by adults aged twenty-one (21) and older; and

WHERE, the Act further establishes a comprehensive regulatory licensing scheme for commercial recreational (adult use) cannabis operations, use, and possession; and

WHEREAS, the Act establishes six (6) marketplace classes of licensed cannabis business, specifically including retail sales as a Class 5 license; and

WHEREAS, Ord. No. 2023-02 as approved on March 13, 2023 by the Borough Council of the Borough of Flemington authorizes two (2) Class 5 retail licenses; and

WHEREAS, pursuant to N.J.A.C. 17:30-5.1(a)(4), a local municipality may impose a separate local license requirement, which the Borough of Flemington has done pursuant to Chapter 95 of the municipal ordinances thereof; and

WHEREAS, the Borough has undertaken the licensing process pursuant to Section 95-7 of the municipal ordinances thereof, having reviewed the application of Aunt Mary's LLC for said license;

WHEREAS, Aunt Mary's has been granted a medical license by the Borough of Flemington and is presently operating an authorized facility at 100 Reaville Road in the Borough; and

WHEREAS, Aunt Mary's has been granted an annual license by the New Jersey Cannabis Regulatory Commission; and

WHEREAS, the Borough Council of the Borough of Flemington desires to award one (1) retail cannabis license to Aunt Mary's of Flemington, New Jersey under the terms and conditions of N.J.S.A. N.J.S.A. 24:6I-31 et seq., N.J.A.C. 17:30-1 et seq., Section 95-1 et seq. of the Borough's municipal code, and the Cannabis Business Application as submitted by Aunt Mary's LLC (attached hereto as Schedule A);

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Flemington, County of Hunterdon, State of New Jersey, that one (1) retail cannabis license is hereby awarded to Aunt Mary's of Flemington, New Jersey; and

BE IT FURTHER RESOLVED, that Aunt Mary's LLC shall tender all fees associated with the issuance and maintenance of this license as authorized in Section 95-4 and 95-6 of the Borough's Municipal Code; and

BE IT FURTHER RESOLVED, that the Borough Clerk of the Borough of Flemington shall issue a Class 5 retail license to Aunt Mary's LLC pursuant to Section 95-5 of the municipal code thereof upon the completion of all other statutory, regulator, and municipal requirements and any requirement, promise, or representations made in Aunt Mary's, LLC's Cannabis Business Application; and

BE IT FURTHER RESOLVED, Aunt Mary's, LLC shall have a continuing obligation to comply with all statutory, regulator, and municipal requirements and any requirement, promise, or representations made thereby in the aforementioned Cannabis Business Application; and

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be provided to the applicant's appropriate representative; and

BE IT FURTHER RESOLVED, that this resolution shall take effect upon adoption by the Borough Council of the Borough of Flemington.

WHEREAS, the Borough of Flemington's new Police facility is in need of a HVAC for the lower level; and
